
Tips for ATM Safety & Security

- Always pay close attention to the ATM and your surroundings.
- Be wary of people trying to "help" you with your ATM transaction.
- Do not use an ATM that appears unusual looking or offers options with which you are not familiar or comfortable.
- Do not allow people to look over your shoulder as you enter your PIN code.
- Do not re-enter your PIN if the ATM "eats" your card – contact a credit union employee immediately.
- Never write your PIN on the back of your card.
- Do your automated banking in a public, well-lit location.

- Never count cash at the machine or in public.
 Wait until you are home, in your car or in another secure place.
- When using a drive-up ATM, keep your engine running, your doors and windows locked, and leave enough room between your car and others in the ATM driveup line.
- Closely monitor your statements, as well as your balance, and immediately report any problems to the credit union.

With an LCLFCU ATM or Visa Check Card, you can access money from your account 24 hours a day from thousands of ATMs and merchant locations worldwide. With the Visa Check Card, you will have the additional flexibility to make purchases online, over the phone or face to face.

Simply fill out the card application and return it to the credit union. Once approved, you will receive your ATM/Visa Check Card in the mail, followed by your Personal Identification Number (PIN). The PIN allows you, and only you, to access your account.
